

**2018/2019 BUILT FORD PROUD SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE, TEST DRIVE, OR SALES PRESENTATION NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.**

**DESCRIPTION:** The 2018/2019 Built Ford Proud Sweepstakes ("Sweepstakes") begins at 12:00 AM Eastern Time ("ET") on 11/1/18 and ends at 11:59 PM ET on 9/30/19 ("Sweepstakes Period").

**SPONSOR:** Ford Motor Company, One American Road, Dearborn, MI 48126.

**ADMINISTRATOR:** Exposure Marketing & Promotion, Inc., 1000 North Opdyke Rd, Auburn Hills, MI 48326.

**ELIGIBILITY:** The Sweepstakes is open to legal resident of the United States and D.C. who are current Farm Bureau members as of 11/1/18, 21 years of age or older with a valid driver's license at the time of entry ("Entrant"). State and County Employees, agents, directors and officers and their immediate families (if they reside in the same household) (spouses and siblings, parents and children and their spouses) and household members of Ford Motor Company ("Sponsor"), Farm Bureau (with the exception of county Farm Bureau volunteer Board of Directors), One Magnify, Exposure Marketing & Promotion, Inc. ("Administrator") and their respective parent companies, subsidiaries and affiliates, distributors, dealerships and companies involved in the implementation and execution of the Sweepstakes (collectively the "Sweepstakes Entities") are not eligible. Sweepstakes is void in Puerto Rico, and other US Commonwealths, Territories and jurisdictions (including overseas military installations) and where prohibited. For the avoidance of doubt, the Sweepstakes Entities, with the exception of Ford Motor Company, are not Sponsors of this Sweepstakes.

**AGREEMENT TO THE OFFICIAL RULES:** By participating in the Sweepstakes, each participant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes. - 3) VIA TEXT – Send the word SWEEPS as an SMS text message from your mobile device to shortcode 46786 ("SMS Entry"). You will receive a link to the entry form. Click on the link and provide the information as requested. You must have an MMS enabled device with text messaging capabilities to enter by text message. Some mobile providers may block messaging to short codes. Not all wireless carriers participate. Standard message and data rates will apply. Check with your wireless service provider for details on these and other applicable charges. Participants are solely responsible for any such message, data, and wireless charges. Each SMS Sweepstakes text entry will generate a text response. Opting-in to receive additional

**LIMIT: One (1) Entry per person or email address, regardless of method of Entry.** In the event more than one (1) Entry is received from any one person or email address, the first Entry processed will be considered the only valid Entry received. In the event of a dispute, online Entries will be deemed made by the authorized account holder of the email address submitted at the time of Entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Any potential winner may be required to show proof of being the authorized account holder. **SWEEPSTAKES WINNER SELECTION:** The potential Sweepstakes Grand Prize winner will be selected in a random drawing conducted on or about 10/10/19 from among all eligible Entries received. Odds of winning Grand Prize depends on the number of eligible Entries received. Sweepstakes drawing will be conducted by Administrator, an independent judging organization. Potential Grand Prize winner will be contacted by 11/1/19 by the Administrator by telephone and/or email and will be required to complete and return an Affidavit of Eligibility and Liability Release and except where prohibited by law, a Publicity Release Form ("Affidavit/Release") within five days of receipt. If the prize notification is rejected, returned, or deemed undeliverable or the potential winner fails to execute and return the Affidavit/Release within the specified time or if he/she is otherwise ineligible to receive the prize, that potential winner will be deemed ineligible and the prize will be forfeited or awarded to an alternate as solely determined by Sponsor. In the event that the potential Grand Prize winner is disqualified for any reason, that prize will be forfeited and awarded to an alternate.

**PRIZES (APPROXIMATE RETAIL VALUE – ARV):**

**ONE (1) GRAND PRIZE:** A 24-month lease on a 2019 Ford Mustang. The Approximate Retail Value ("ARV") of the prize is \$15,000. ARV is based on a 24-month lease of a 2019 Ford Mustang EcoBoost Coupe and ARV and/or lease duration. Value of the prize may change when additional leasing information is made available in October 2019. Lease is subject to all conditions imposed by grantor including 12,000 miles per year maximum. Winner is subject to credit approval from Ford Motor Credit and will be responsible for execution of and compliance with the standard form of "Red Carpet Lease" through Ford Motor Credit Company. Winner is responsible for any and all taxes, title, plate fees, documentation fees, full-coverage insurance, additional miles in excess of the 12,000 per year (as defined above) and for all costs associated with any available upgrade/option not provided with the prize vehicle and any other expenses related to the acceptance and use of the prize not specified. Winner must take delivery within 30 days of vehicle award date at a Ford dealership specified by Sponsor. Winner must have a valid

U.S. driver's license and proof of insurance to take delivery. Vehicle awarded may differ from any vehicle shown in Sweepstakes materials. Vehicle color, options and equipment may be determined by Sponsor in its sole discretion.

**TWO 2) FIRST PRIZES:** A \$1,000 Gift Card. Issuers of gift cards will be determined by Sponsor in its sole discretion. Gift cards are subject to their terms and conditions as indicated thereon. Total ARV of all First Prizes is \$2,000.

Total ARV of all prizes is \$17,000.

**GENERAL PRIZE RESTRICTIONS:** Prizes may not be transferred or assigned. No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute the prize in whole or in part with another prize of comparable or greater value if the intended prize is not available for any reason as determined by the Sponsor in its sole discretion. Winners will be responsible for all taxes (federal, state, local and/or income) and all expenses not listed related to acceptance and use of prize. Prize Winners will be required to provide, to Administrator, his/her Social Security number or tax ID for tax reporting purposes on any prize valued over \$600. Administrator will file an IRS Form 1099 with the Internal Revenue Service reflecting the First Prize value and the actual lease value of the Grand Prize vehicle. In the event that the actual value of the Grand Prize is less than its stated ARV, that Grand Prize Winner will not receive the difference in value.
